1. PURPOSE

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

What is this product?

Type: Senior, Unsecured, Bearer, Medium Term Certificates (English law governed).

Objectives: The product is designed to provide a return in the form of a cash payment on the **Settlement Date** that will depend upon the performance of the **Underlying**. You accept the risk of loss of some or up to 80 per cent. of your investment as during the time you hold the product, the value of the Underlying may fall, in which case the product will return less than your initial investment and may return only 20 per cent. of your initial investment. Terms in **bold** are described in more detail below.

An **Automatic Early Redemption Event** will occur, and the product will terminate early, if on any day on which the Underlying is trading, the (1) monthly NAV of the Underlying divided by (2) the NAV of the Underlying on 13th November 2019 is equal to or less than 30 per cent. (the **Automatic Early Redemption Level**). If an Automatic Early Redemption Event occurs, you will receive the **Automatic Early Redemption Amount** on the **Automatic Early Redemption Date**. Note that payment amounts are calculated as a percentage of the Denomination, which may not be the same as the price at which you purchased the product.

The Certificateholder has the right, but not the obligation, to exercise the Certificateholder's Put. In order to exercise the Certificateholder's Put the certificateholder must submit to the Issuer a notice at least 40 calendar days before the **Optional Redemption Valuation Date**. If the Certificateholder's Put is exercised you will receive the **Optional Redemption Amount** 60 business days after the **Optional Redemption Valuation Date**.

If the product does not terminate early, the Final Settlement Amount you will receive on the **Settlement Date** will be a cash amount equal to (1) the **Denomination**, multiplied by (2) the ratio of the NAV of the **Underlying** on the **Valuation Date** and the NAV of the **Underlying** on 13th November 2019, subject to a minimum of 20 per cent of the **Denomination**.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to changes in law, the Underlying, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

Returns from an investment in the product may be achieved by means of the purchase and subsequent resale of the product.

Risk & Reward Profile

5. WHAT ARE THE COSTS?

6. HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 1 Year
