This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

#### What is this product?

**Type:** Senior, Unsecured, Bearer, Medium Term Certificates (English law governed).

**Objectives:** The product is designed to provide a return in the form of a cash payment on the **Settlement Date** that will depend upon the performance of the **Underlying**. Terms in **bold** are described in more detail below.

An **Automatic Early Redemption Event** will occur, and the product will terminate early, if on any day on which the Certificate is trading, the (1) price of the Certificate divided by (2) the **Denomination** is equal to or less than 30 per cent. (the **Automatic Early Redemption Level**). If an Automatic Early Redemption Event occurs, you will receive the **Automatic Early Redemption Amount** on the **Automatic Early Redemption Date**. Note that payment amounts are calculated as a percentage of the Denomination, which may not be the same as the price at which you purchased the product. If the product does not terminate early, the Final Settlement Amount you will receive on the **Settlement Date** will be a cash amount equal to (1) the **Denomination**, multiplied by (2) the ratio of the official closing level of the **Underlying** on the **Valuation Date** after a 10% risk control methodology has been applied and the official closing level of the **Underlying** on the **Issue Date**, subject to a minimum of 100 per cent of the **Denomination**. Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to changes in law, the Underlying, the product and the product issuer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

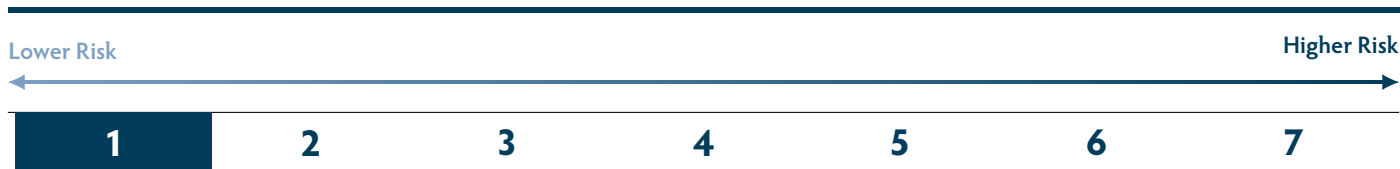

### 3. WHAT ARE THE RISKS & WHAT COULD I GET IN RETURN?

#### Risk & Reward Profile



- The risk indicator assumes you keep the product one year. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. ### 5. WHAT ARE THE COSTS?
